



## Stroud Community Web **Content and Conduct Policy**

This following policy plays an essential role in ensuring a positive experience for everyone who interacts with Stroud Community Web. As administrators of this site we see it is our role to ensure that the content is acceptable for everyone in the community.

1. All content on the site will be in keeping with the Lions Club code of conduct.
2. All written material on this site is the property of Stroud Lions Club.
3. All site content (including comments and contributed words and photos) will be reviewed prior to being uploaded to the Stroud Community Web. If it is not considered acceptable under the terms of this policy, it will not be published.
4. If you are concerned about the non-publishing of your comment or content please contact the site administrator at [stroudnsw@hotmail.com](mailto:stroudnsw@hotmail.com)
5. If you disagree with any of the content on the site please contact the site administrator at [stroudnsw@hotmail.com](mailto:stroudnsw@hotmail.com)
6. Any comments that are inflammatory or contain profanity, abbreviated or otherwise, **will not be published.**
7. All posted comments will contain the first name of the person making the comment.
8. We will only publish submitted photographs if you are the owner of that photograph and you have permission to publish from everyone in the photograph.
9. Every reasonable effort will be made to gain permission to publish from everyone in photographs taken by Stroud Community Web administrators for the express purpose of community news dissemination.
10. If you are putting an item up to sell or swap on the Swap Spot it is assumed that you are the owner of that item.

11. Stroud Lions Club, through SCW, provide free advertising for community events and services where there is an unquestionable benefit to the community arising from the advertised event or service. Where event organisers or service providers take profits from the event or service, or where the need for the event or service arises from a profit-taking commercial activity, it is expected that the profit-taking business will pay for advertising.
12. Stroud Lions Club and the SCW administrators will consider each request for free advertising on a case-by-case basis to ensure a consistent application of this policy, and to give opportunity for the merits of each request to be considered. The acceptance of all advertising (free-of-charge or paid) will in every case be at the ultimate discretion of Stroud Lions Club.
13. All personal information and email lists are confidential and will not be handed on to a third party for advertising. They will only be used to send News Posts in relation to the Stroud Community Web. (See our privacy policy for more information.)
14. Businesses or groups that promote hatred or violence towards other groups of people based on their race or ethnic origin, religion, disability, gender, age, veteran status, or sexual orientation/gender identity will **not be permitted** to advertise with the Stroud Community Web.
15. Businesses or groups that engage in illegal activities or promote dangerous and illegal acts or exploit children in anyway will **not be permitted** to advertise with the Stroud Community Web.

*This Content & Conduct Policy will be signed by the president of each new board of the Stroud Lions Club at their first board meeting with the current providers of the Stroud Community Web. This will cover the next 12 month period unless there is a need for an amendment during that time.*
